The Financial Results are accordance with Indian Accounting Standard (Ind-AS) as prescribed under Sectin 133 of the Companies Act, 2013 read with Rule 3 of Companies (Indian Accounting Standard) Rules, 2015 and Companies (Indian Accounting Standard) Rules, 2016, The Result have been audited by the Statutory Auditors of the Company.
- 2 The Company has adopted Indian Accounting Standard ("IND AS") effective from 1st April 2019 (Transition date being 1st April 2018) and accordingly the Financial Results for the Quarter / year ended 31st March, 2020 have been prepared in accordance with the recognition and measurement principles laid down in Ind As precribed under section 133 of the Companies Act' 2013. ("the act") read with relevant rules issued thereunder and other relevant provisions of the act. The Impact of transaction to Ind AS has been accounted for in the Other Comprehensive Income and Comparative Previous year figures have been rested accordingly
- 3 Fair valuation of Financial Instruments: Company has valued certain financial asset at fair value. The impact of change in fair value as on the date of transaction (i.e. 01/04/2018 is recognised in opening equity and the changes thereafter in the Statement of Profit and Loss or other Comprehensive Income as the case may be.
- 4 The figures for the 3 Months ended on March 31, 2020 are the balancing figures between the audited figures in respect of full financial year and published unaudited year to date figures upto the 9 Months of the respective financial year. which were subjected to Limited Review Report by the Auditors.
- 5 The spread of SARS-COV-2 virus (referred as 'COVID-19') across the global and in India has contributed to a significant decline and volatily in global and Indian financial markets and a contraction in the economic activities. On March 11, 2020 COVID-19 outbreak was declared as a global pendemic by the World Health Organisation. The Indian Government announced a strict 21 day lockdown on March 24, 2020 which is being extended from time to time with or without relaxations across the country based on the severity of the spread at local levels. The extent to which the COVID-19 pandemic will impact the operations and financial results of the Company and consequently the estimates and judgements made coule very on future developments, including among other things any new information concerning the severity of the COVID-19 pandemic and any action to contain its spread or mitigate its impact wheter government mandated or elected by the Company, which are uncertain as at the date approval of these financial results. The Company continues to closely monitor any material changes to future econimic conditions, which will be given effect in the respective future period. However, considering the overall condition of the economy and the interventions of the Government to rusure revival of economic activity, the company does not consider that there is any uncertainity regarding the assumption of going concern.
